

THE MUSIC BUSINESS NETWORK'S TERMS & CONDITIONS

Site Ownership:

The Site is the property of The Music Business Network L.L.C. ("The Network"). 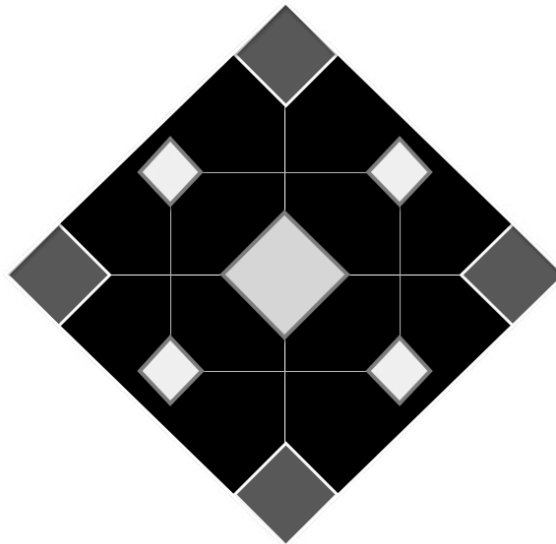
